EARNEST MONEY DEPOSIT FOR AUCTION: Upon acceptance of the auction bid the buyer shall have to pay Earnest Money @ 25 % of material value against accepted bids positively within 7 days of confirmation of bid by Demand Draft/Pay Order on any Nationalized/Scheduled Bank in favour of CIWTC Ltd. payable at KOLKATA (PREBID EMD WILL NOT BE ADJUSTED WITH THE 25% EMD). 11. ISSUANCE OF SALE ORDER/ACCEPTANCE LETTER:- WILL BE ISSUED AFTER SALE. Bid Detail and Acceptance of Highest Bid to be intimated to M/s. Lots Shipping Ltd. the Respondent as directed by the Hon'ble High Court, Calcutta. On receipt of 25% EMD at any offices of MSTC under intimation to MSTC, ERO a sale Order will be issued by MSTC for sold lots. This 25% is in addition to the PREBID paid for the auction.

12. BALANCE PAYMENT:

13. PAYMENT DETAILS ARE AS BELOW:

#### 14. TAXES & OTHER LEVIES:

The applicable rate of VAT is 14.5% on the material value and other TAXES as mentioned in the auction catalogue will be applicable. Any other duties if any, over the price quoted/auctioned along with the full balance payment for issue of Sale Order. Such Taxes are assessed by the Sales Tax Authorities and hence the rate applicable at the time of lifting of material shall be binding on the bidders for making payments. Any dispute in this regard shall be taken up directly by the bidders with the Statutory Authorities. NOTE: Form - 'C' will not be accepted by owner in case of interstate sale. #### 15. INCOME TAX:

Income Tax @ 1.00% on purchase price will be charged. Purchase price means base price + sales tax. Exemption will be given to manufacturers and processors on production of exemption certificate from the concerned assessing officer of the income tax department. Exemption is not available to retailers/traders.

#### 16. DELIVERY PERIOD:

The successful bidders shall lift the specific material lying in the lot allotted to them by employing their own labour and transport at their own cost within 90 Calendar Days (ninety Days) from the date of Delivery Order (excluding date of issue) by MSTC or 90 Calendar days from the date of issuance of Sale Release Order by owner. THE MATERIALS WILL BE DELIVERED BY THE OWNER TO THE SUCCESSFUL BUYER AGAINST PRODUCTION OF THE FOLLOWING :-

#### 17. PERIOD OF CONTRACT:

The contract shall be treated as having entered into as soon as a letter of Acceptance is issued by MSTC to the successful bidder. The successful bidder should mobilize men & material so as to remove the scrap barges from the river system in 90 (ninety) days. The contract shall be deemed to be completed as soon as the area is cleared by the successful bidder of the entire materials allotted and fulfillment of all the statutory and contractual obligations. In case of delay/defer, the liability arisen, if any, would have to be borne by the successful bidder. THE CONTRACT SHALL BE VALID UPTO THE VALIDITY PERIOD OF THE DO/SALE RELEASE ORDER ISSUED BY MSTC/PRINCIPAL OR UPTO THE EXTENDED PERIOD OF VALIDITY OF THE DO/SALE RELEASE ORDER IN CASE THE DELIVERY PERIOD IS EXTENDED BY THE PRINCIPAL AT THEIR SOLE DISCRETION AS THE CASE MAY BE.

18. The successful bidder shall be allowed to start dismantling work only after full payment including all charges alongwith VAT and other levies.

#### (i) SUPERVISION OF THE JOB:

(ii) Shri R.Gangopadhyay, Technical (Manager), T.T.Sheds, 6, Garden Reach Road, Kolkata 700 043; Phone No. (033)-2439-7929 (O), or his authorized representative will supervise the job of disposal so as to complete the same as per terms and conditions of the e-auction.

#### (iii) SCOPE OF WORK:

(iv) Disposal of M.V.Moulana Azad as condemned vessel lying at Sea Hard of Rozi Dock, Jamnagar, Gujarat and M.V.Wazed Ali as condemned vessel lying at Sea Hard of Rozi Dock, Jamnagar, Gujarat on "As-is-where-is" basis.

(v) REMOVAL OF ALL MACHINERIES FITTED ON BOARD/EQUIPMENT/ITEMS.

(vi) Disposal including transportation of the goods/materials / equipment shall be the sole responsibility of the successful bidder including all necessary formalities like Police, Pollution, Customs etc. at his cost and risks, taking all safety precautions. During disposal precautionary measures are to be taken to avoid any type of environmental pollution.

(vii) The successful bidder will arrange to remove the dismantled materials and clear the site as directed within the stipulated time.

19. The material will have to be removed on AS IS WHERE IS BASIS at the bidder's own cost and expenses. The successful bidder shall not be provided with any manpower or any equipment etc. by Owner (CIWTC Ltd.) for dismantling / loading/unloading/transportations etc. The successful bidder will have to arrange for any / or all of these at their own cost.

(i) The successful bidder shall have to comply with all the statutory rules and regulations as per the existing laws and environmental pollution control norms prevailing in the State of West Bengal during the entire period of execution of the job removal.

(ii) The debris etc. to be generated on account of this dismantling/removal work is to be cleared and to be taken out at his own cost.

(iii) All precautions shall be taken by the bidder not to hamper or create disruption in normal working. The successful bidder shall be responsible to keep/post their site-in-charge and Engineer/Supervisors having adequate experience in such type of dismantling & disposal work.

(iv) DISMANTLING & DELIVERY OF THE MATERIALS:

(v) The purchaser at his own cost will make his own arrangement for removal, dismantling, loading, transporting and he will not be entitled to claim any facility or assistance or cost on this account from CIWTC Ltd. (Principal).

(vi) Since the items are being disposed on LOT basis and also on AS IS WHERE IS BASIS no claim shall be entertained by CIWTC Ltd. for shortage/ inconvenient/condition of any items, if any.

(vii) For the purpose of removing the materials, the purchaser shall employ or engage only his/her/their own personnel and shall keep CIWTC Ltd. & MSTC Ltd. fully indemnified against any claim whatsoever including claim for wage, injuries, compensation, death etc.

(viii) The buyer shall at his own cost protect, support and take all precautions in regard to the personnel or structure or services or properties belonging to the CIWTC or not, which may be interfered with or affected or disturbed or endangered and shall indemnify and keep indemnified against claim for injury, loss or damage causes by the buyer in connection with the execution of dismantling and disposal work to the aforesaid properties, structures and services and/or to any person including the buyer s workmen. Cost of Insurance Cover, if any, taken by the buyer shall not be reimbursed by the owner (CIWTC Ltd.).

## 20. COMPLETION PERIOD/TIME FRAME :

Complete job of dismantling and disposal including clearing shall be completed in all respect by the successful bidder by employing their own labour and cost. All required tools and tackles shall be arranged by the buyer.

21. Upon completion of dismantling & cleaning of the scrap materials the successful bidder would submit Demolition Certificate to CIWTC with a copy to MSTC and this Certificate would be conclusive evidence of scrapping and not for re-use.

22. ENGAGEMENT OF LABOUR : The bidder shall have to follow all other statutory regulations/obligations from time to time as per labour laws prevailing in the India and in the state of West Bengal.

23. INSURANCE OF SUCCESSFUL BUYER S PERSONNEL : The successful bidder must cover the employees/workers engaged by him for the job under Workmen Compensation Insurance Policy and intimate to CIWTC Ltd.

24. SAFETY REGULATION : The successful bidder shall be responsible to follow normal safety instructions issued by the Govt. of West Bengal from time to time and other safety regulations of India. Any loss/damage caused to the property of CIWTC Ltd. has to be made good by the successful bidder.

25. FIRE PROTECTION: Gas cutting work to be carried out by the successful bidder in course of dismantling work etc. will be allowed only under supervision of bidder s supervisory personnel who will ensure that all safety precautions have been taken including those for prevention of fire and other hazards in and around the area.

26. FACILITIES TO BE PROVIDED BY THE SUCCESSFUL BIDDER: All tools and plants (fulfilling all safety requirements) including other arrangements of dismantling, removal, loading and transportation of the materials have to be made/arranged by the successful bidder. The owner does not take responsibility for providing Oxygen / DA cylinders or any other consumables to the bidder for dismantling/disposal job.

27. SECURITY OF SOLD MATERIALS & EQUIPMENTS : The successful bidder shall make his own arrangements for the security of materials sold to him under the Sale Release Order. In no case, CIWTC Ltd. will be responsible for any loss or theft of such materials already sold to the bidder. The bidder will be responsible for safe custody of his own tools, tackles and other materials.

28. STATUTORY OBLIGATIONS : All the statutory obligations not specified above but are supposed to be fulfilled by the bidder/contractor including Environmental Pollution Control Norms, as required to be followed, are included in the contract for its fulfilment and therefore, shall keep CIWTC Ltd./MSTC indemnified for all the consequences in case of default reported by any statutory agency. The successful bidder shall comply with all applicable West Bengal & Central laws, statutory rules, regulations etc.

29. FORCE MAJEURE : In the event of either party being rendered unable by Force Majeure to perform any obligation required to be performed by them under the Contract, the relative obligation of the party affected by such Force Majeure shall, upon notification to the other party, be suspended for the period during which Force Majeure event lasts. The cost and loss sustained by either party shall be borne by the respective parties. The term FORCE MAJEURE as employed herein shall mean acts of God, Earth-quake, War, Revolts, Riots, Fire, Floods, Sabotage, change in Govt. regulation, Hurricanes/Cyclones and Strikes, excluding strikes by their Sub-Contractors. Upon occurrence of such cause and upon its termination, the party alleging that it has been rendered unable as aforesaid, shall notify the other party in writing immediately but not later 07 (seven) days after the alleged beginning thereof, giving full particulars and satisfactory evidence in support of its claim.

30. ARBITRATION/JURISDICTION : The contract shall in all respect be construed and operated as an Indian Contract and in accordance with the Indian Laws in force and subject to exclusive jurisdiction of Calcutta High Court.

31. NOTE : CIWTC Ltd. as the seller has the sole authority to accept or reject any offer without assigning any reason whatsoever. In case of overseas sale, all relevant customs and port related rules & regulations shall be followed by the Buyer. The additional financial implication, if any, in this account shall be to the buyers account.
